Note: In June 1880, a meeting of certified marine engineers in Sydney formed the Sydney Association of Marine Engineers; from this group came the impetus to form the Australasian Institution of Marine Engineers in c. January 1881. In August 1922 the title was amended to the Australasian Institute of Marine and Power Engineers, and in November 1924 to the Australian Institute of Marine and Power Engineers, the New Zealand District having gained autonomy from that date.
