The Woolclassers' Association of N.S.W. was registered under the Trades Union Act of 1881 on 6 September 1909. It registered federally on 3 January 1934, changed title to Woolclassers' Association of Australia and had 2 branches, one in N.S.W. and one in Victoria. By 1919 there was an association in W.A. called the Woolclassers' & Experts Association of W.A. and in 1930 there was talk of amalgamation with the N.S.W. Association but this was not effected until 1950. The South Australian branch affiliated in 1944 after its formation then. In Queensland the woolclassers' were covered by the A.W.U. award and a branch was not formed until 1962 and it affiliated with the W.A.A. in 1963.
