The F.I.A. of A. entered into an amalgamation agreement with the Arms, Explosives and Munitions Workers Federation by which everyone who was a member of the latter Union on 23 October 1944 became a member of the F.I.A. on that day [Industrial Information Bulletin Vol.2, Jan-June 1947 p.283]. The intention was that the combined unions became the Metal and Munitions Union but continued applications over a number of years failed to result in registration of the new name, the name of Federated Ironworkers' Association continued.

In 1945 the F.I.A. applied unsuccessfully for change in conditions of eligibility in order to amalgamate with the Federated Artificial Fertiliser and Chemical Workers' Union of Australia, as had been agreed by both Unions in March 1943. The latter union continued to exist separately in Victoria and South Australia despite the purported amalgamation [Indust. Info. Bull. 1947, Jan-June]. On 24 March, 1948 registration of the Federated Artificial Fertilizer and Chemical Workers' Union was cancelled.

In 1945 (?) the F.I.A. also amalgamated with the Wire Workers Union under the name of the former union.
