Irwin papers on smallholder rubber production in Papua,
1968-1973

- 3 slide boxes labelled “New Guinea D,” “New Guinea E,” and “New Guinea F,” organised with indexes inscribed on the internal lid of the box as follows:
 - “New Guinea D”: Mountains; Vegetation (Rain forest, Savannah); Vegetation (Swamp); Vegetation (Aerial, Fly River, Coastal); Aerial Villages; Effects of gardening; Gardening- Bakoiudu; Gardening Murua; Gardens: Ombisusu, Trobriands, Western District; Village housing Murua; Village housing Trobriands and Coastal; Village housing: Bakoiudu, Kiunga, Tara Ombisusu.
 - “New Guinea E”: Sago; Villagers; Cooking; Feast; Village activities; Portraits; Village services; Transport: foot, canoe; Transport- ships; Transport- air
 - “New Guinea F”: Monuments; Somare; Port Moresby: aerial, squatter housing; Housing- squatter, no-covenant, low-covenant, high-covenant; Housing- high-covenant, university, Koki; Housing- Kerema, aeriels; Rubber trees; Factories, S/Houses; Tapping, Transporting, Straining; Coagulating, Rolling; Baling, Marketing; Cape Rodney
- Index cards. Originally grouped with rubber bands that have disintegrated and been replaced with cotton tape in the original groupings. Some arranged by location, others by topic.
