- 13/96 Computer print-out showing gross earnings of staff at Port Kembla for year ended 30.6.1974
- 14/96 A report by the Assistant General Manager, L.F. White, summarising plant improvements in the period 1933-53.
  - 15/96 Shareholding structure of Vinidex Tubemakers Pty Ltd., 1977 and 1979
- 16/96 Agreement of 1921 to purchase the copper tube making plant of Hugh Victor McKay at Sunshine, Victoria.
- 17/96 Memorandum from Assistant Managing Director dated March 1969 advising staff of decision to discontinue payment of annual staff bonus
- 18/96 Memos etc dealing with the pricing of inter-company transfers. Metal Manufactures from its Port Kembla works supplied its partly-owned subsidiary, Cable Makers Pty Ltd at Liverpool, NSW, with bare copper wire used in the manufacture of various electrical conductors. The transfer price charged to CMA by MM was always a sore point with the cable company who claimed it put them at a disadvantage with their competitors. MM's philosophy, however, was to maximise the profit at their Port Kembla works at the expense of a greater profit for the cable company, of which they would only get a share.
- employment of Mr 19/96 A file dealing with the terms of Kirkpatrick. Mr Kirkpatrick came out under contract from Metal Manufactures' English shareholder and technical advisor, British Insulated Cables, to establish Telephone Cable Factory at Port Kembla. Later he became Assistant General manager and subsequently General Manager at the Port Kembla Works. This file is of particular interest in that it refers to a 34% reduction in salary which applied to all staff in these days of the Great Depression. Mr Kirkpatrick, being on a contract, objected to this, thereby, incidentally, incurring the displeasure of his fellow staff members.
- 20/96 Plan showing the layout of the Port Kembla Works in 1973. The area shaded in red was known as the "A" Tube Mill, and having become technologically obsolete, became the site for the installation of the Southwire Continuous Copper rod casting and rolling plant, known locally as "The K.C.R. plant".

22/96	Trust Deed between Metal Manufactures Ltd, National Mutual Life Nominees and Austral Bronze Company Pty Ltd, dated 29th January, 1960

24/96	"Early History of Austral Bronze Company Limited". This Company became a fully-owned subsidiary of Metal Manufactures Ltd. This history was prepared by Mr (Stewardson, a man who had a long involvement with the non-ferrous industry in Australia, and who was also involved in the formation of Austral Bronze. This is an important document.
