Note:

This organization was first known as the Mercantile Marine Officers' Association. A General Meeting of members held on 12 February 1904 agreed to adopt the name the Merchant Service Guild of Australasia. On 3 September 1957 the name of the union was changed to the Merchant Service Guild of Australia.

The Guild was registered under the Commonwealth Conciliation and Arbitration Act of 1904 on 5 May 1905. It was the first employee organization to be registered under this act.

The union covers anyone holding a certificate of compentency to do with the safe navigation of vessels. Initially the Guild was formed by the Mates Merging with the Masters. In 1907 the Coast Trade Masters and Officers' Association was asked to join and at a General Meeting held on 14 April 1919 it was agreed to invite engineers to join who were not eligible for membership of the Australian Institute of Marine and Power Engineers. In January 1979 the union amalgamated with the seagoing Shipwrights.

There are six main categories of members - offshore members; tugs; pilots; shore based members; marine engineers and drivers and seagoing shipwrights.

The union has branches in Queensland, Victoria/Tasmania; South Australia; NSW and Western Australia. The Victorian Branch was the first to be established in 1905.
