BOX LIST NOTE

These records were located in the Victorian Branch Office of the Australian Timber Workers Union. For many years the Federal business was conducted from the Victorian Branch Office, with the further complication of the Victorian Branch Secretary and the Federal Secretary being the same person. These records were culled by the present Federal Secretary when he took over the position. The Federal Office is now based at the S.A. Branch office.

The state of the office files (Boxes 19 to 34) is rather chaotic, with some containing both Federal and Victorian records and most having no internal order. Occasionally the file titles seem to have little relevance to the contents. The Archivist who compiles the series list for these records would be well advised to first clarify the administrative functions and personnel of the Federal Office and the Victorian Branch. The most likely records to give these details are the Minutes of the Federal Council Meetings (Boxes 1-3); rules (Boxes 6-8) and The Timber Worker (Box 9).

Victorian Branch archival records have been deposited with Melbourne University Archives. Some Victorian Branch records have been transferred with this deposit (see Box 36) mainly because of the confused state in which the records were kept.

Office Files - These records were stored in the bottom of two drawers of two four-drawer filing cabinets in the Victorian Branch Office. They represent the remnants of the Federal Office general filing system culled by the new Federal Secretary (based in SA).

Office Files (cont)

There appears to have been two filing systems, however, at the date of packing and preparing the box list the distinction was not clear. For this reason a decision was made to make one subject/alphabetical system. Please note when compiling the series list that the alphabetical arrangement within each letter is not precise. Papers within the files are in a bad state of disarray, and a close look at the file titles in respect of the contents of each file will be necessary.

The system is complicated further by the fact that the Victorian Branch Secretary and the Federal Secretary were one and the same person for a number of years.
