NOTE An important wool-broking firm originally established by Richard Goldsbrough in Melbourne in 1848. In 1881, after an amalgamation with the Australian Agency & Banking Corporation Ltd., it became a limited company under the name R. Goldsbrough & Co.Ltd., The purchase in 1888 of the Sydney firm, Mort & Co.Ltd. (established by Thomas Mort in 1843) led to a change of name to Goldsbrough, Mort & Co. Ltd., as the firm remained, inspite of alterations in its financial structure and DESCRIPTION the purchase of other businesses, until the merger with Elder Smith & Co. Ltd. in 1962.

The records fall into two main categories: records of the business proper, and records of the various station properties with which it was concerned. The first section comprises minutes of Board meetings, Board papers, correspondence, account books, papers relating to shares, legal papers, branch letters, and presscuttings. The station material includes correspondence, returns, reports on stations, account books, clients' documents, papers relating to land matters and maps. A small subgroup consists of papers relating to property owned by the Company in the Northern Territory, from which a live-cattle business was carried on between Darwin, Bataviand Singapore in the 1880s and 1890s.


