The A.P.W.U. registered under Commonwealth Conciliation and Arbitration Act on 26 Feb 1926, was formerly entitled the Amalgamated Postal Linemen, Sorters and Letter Carriers Union of Aus., which was formed by the amalgamation in 1925 of the Ausn. Letter Carriers Association, the Ausn. Postal Linemen's Union and the Postal Sorters Union of Aus. These three unions had themselves been formed through the federation of several State associations. The A.L.C.A., which was registered in Victoria under the C'wealth Conciliation and Arbitration Act on 25 Sep 1912, was a combination of probably seven unions; the A.P.L.U. was a federation of five associations and, prior to 1918, was known as the Ausn. Telegraph & Telephone Construction and Maintenance Union; and the P.S.U.A. was a federation of five State unions.
