Note: Lincoln Mills (Australia) Ltd. was established in 1926 to take over a company established in 1922 to operate the manufacturing companies Lincoln Mills Knitting Pty. Ltd. and Lincoln Mills Spinning Pty. Ltd. (In 1931, a new system of trading was initiated under which the whole of the production of the subsidiary companies was distributed by Lincoln Mills (Australia) Ltd. In 1939, the two subsidiary companies of Lincoln Mills Knitting Pty. Ltd. and Lincoln Mills Spinning Pty. Ltd. were wound up and the assets acquired by Lincoln Mills (Australia) Ltd. which then carried on both the distribution and the manufacturing. Profitable trading continued until, after negotiations over a considerable period, Cleckheaton Ltd. (then Cleckheaton (Yorkshire) Ltd.) acquired a controlling interest in the company and its wholly owned subsidiary, Atylex Pty. Ltd., in 1962.)
