The field of operations for this company was woolbroking, pastoral investment, stock and station activities, and sgency handling. The company was incorporated in England in 1865 and a branch - Melbourne (the first in Australia) was established in 1875. The company expended its activities to every state until 1961 when it merged with Dalgety Ltd. A Head Office of the General Manager for Australia was established in 1889 with Mr David Elder as its first General Manager.

Description:

This deposit contains some Head Office material (110)/8/(-32)viz. Correspondence 1947-60; Taxation papers 1910-1961; memorandum and articles of association 1894-1937; material relating to shares 1914-1961 and stock ledgers 1913-1944 (approx. 6% linear feet). Also set of annual reports (printed) 1895-1961. Melbourne branch material includes correspondence with Victorian branches 1934-1961, annual accounts and balance returns 1954-1961, "merger" files showing assets as at 1961, salary sheets 1941-1961, cash receipt books and cheque registers 1958-1962. Departmental material includes Wool Dept. clients records 1894-1962; wool delivery figures 1940-1962; wool store wages sheets 1920-1961; Stock Dept. correspondence 1958-1961. Croydon market records 1958-60. Stud Stock Dept. correspondence 1957-60 and sales material (same date). Tobacco Dept. clients files 1960-61 and returns, charges and catalogues of leaf (same date).
