Note                :    Under its constitution, the Association consists of engine drivers and firemen, crane drivers, dynamo and boiler attendants and others involved in work related to any engine, boiler or machinery (other than drivers of motor lorries).

During the period in which most of the records in this deposit were produced, the Association had strong membership among the maintenance staff and fork lift drivers at the breweries of Tooth & Co. It also had complete coverage of operators employed by Shell Refinery (Australia) Pty Ltd at its Clyde Refinery and Gore Bay terminal. The Association had significant membership in the coal and metalliferous mining, building and construction, power and cement industries, and in the Maritime Services Board of NSW. It also covered boiler attendants and other plant operators in hospitals, abattoirs, dockyards and brickworks; and in manufacturing industries including paper, glass, sugar and other food production.

Details of the government and administrative history of the Association are given in the Note to Deposit N81. It should be noted, however, that the NSW organisation of the Federated Engine Drivers' and Firemen's Association operates as both the Coast District Branch of the Federally registered body, and is also separately registered in NSW as FEDFA(NSW).

**Description** : Office files of minutes and related papers, 1965-1983; administrative files, 1929-1983; correspondence files, and circulars, 1959-1983; subject files, 1917, 1945-1982; industrial files, including award files, arbitration case files and compensation claims, 1927-1985; records of officials and organisers, 1921-1982; printed material and unpublished papers; sundry records including banner, certificates, maps, photographs, etc.; and records of the following Sub-Branches: Lake Macquarie, 1964-1966; Sydney, 1968-1977; Granville, 1942-1979; Central Illawarra, 1952-1980; and Canberra, 1957-1970.

**Arrangement** : The Association's records were originally very loosely organised in an encyclopaedic alphabetically controlled system of office files. Some of the files were held in a central location, others were maintained independently by officials of the Association. Some documents accumulated in bundles which escaped any kind of control. For the purpose of arranging this deposit, loose papers have been filed in the office file series. Files which appear to have been maintained independently by officials are also incorporated in the office file series.

To give shape to an otherwise amorphous system and to facilitate retrieval, the office files have been arranged in categories imposed on them by the Archivist.
