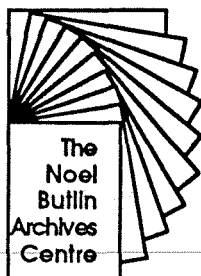

CHRONICLE

History of the Australian Federal Police Association

The Australian Federal Police Association (AFPA) was established on 29 July 1982 after a merger of the Commonwealth Police Officers' Association (CPOA)-a body representing the industrial interests of the Commonwealth police and, the Federal Police Association (FPA)-representing the industrial interests of the Australian Capital Territory police force. From 1942 to 1982, the Commonwealth police had been represented by the Defence Establishments Guard Association (1942-1943), the Peace Officer Guard Association (1943-1958) and the CPOA (1958-1982). Police officers of the A.C.T. had been represented by the ACT Police Officers' Association (1933-1979) and the Federal Police Association (1979-1982).

The impetus for the AFPA was the proclamation of the Australian Federal Police Act on 15 June 1979. This Commonwealth legislation established the Australian Federal Police (a merger of the Commonwealth police and the A.C.T. police), which commenced operations on 19 October 1979. Initially, the CPOA and the FPA continued as separate associations due to ongoing differences between the two associations as to the type of industrial representation members of the newly formed Australian Federal Police (AFP) should have. However, the amalgamation of the Commonwealth police & the ACT police, did result in executive members of both associations forming a working party to pursue the notion that there should be one police association for all members of the AFP.

On 13 November 1980, an application was lodged with the Industrial Relations Commission by the CPOA for consent to change its name to the **Australian Federal Police Association**. Notice of the receipt of the application was presented in the Commonwealth Gazette No.G2 dated 13 January 1981. However, the solicitation by the CPOA was not acted upon: the industrial registrar citing restrictions to such a change vis a vis Australian Federal Police regulations, i.e. the existence of another police association, the FPA within the AFP.

On 3 July 1982, the executive leaderships of the FPA and the CPOA commenced preliminary talks that both hoped would lead to a final amalgamation of both associations. This aim was assisted by a plebiscite of FPA members on the 29 July 1982 that saw a majority result in favour of the FPA merging with the CPOA. On 12 August 1982, a merger agreement (with conditions), was signed by Mr Peter Neil (FPA president) and Mr Ken Dowell (CPOA president). This meant that all FPA members were now deemed members of the CPOA and, that at the request of the FPA, the CPOA would

re-apply under the Conciliation and Arbitration Act to alter its name and, in addition, would also alter its conditions of membership and description of the police industry to embrace the work of the FPA.

On 27 August 1982, the CPOA received the consent of the Industrial Registrar, Mr John McMahon to alter its name to the Australian Federal Police Association. He said that it was in the public interest to have one industrial association representing all AFP members. This new name was entered into the Register of Organisations, together with a certificate of registration. As a result, the AFPA became a registered association under the Conciliation and Arbitration Act 1904 (as amended), thus giving it a certain legal standing under the Act.

Today, the AFPA is an registered organisation pursuant to the Conciliation and Arbitration Act 1904 (as amended). The AFPA is affiliated with the Police Federation of Australia and New Zealand. It is also affiliated with the Australian Council of Trade Unions (ACTU). The AFPA consists of state and territory branches. There is also a commissioned officers' branch.
