The Company has carried on business as wool brokers, merchandise, stock and property agents and as a pastoral company in New South Wales, Victoria and Queensland. By 1970 the Company had been taken over by Wood Hall Trust Ltd in the U.K. although the Australian company has continued to carry on business
