Note : Coal mining began in Australia in 1798 at Newcastle, with convict labour. Some attempts were made early in the 19th century to organise the miners, but it was not until the 1840's and 50's that unions were formed by the miners and craftsmen. However, these were short-lived. The first continuously existing miners' union was formed at Newcastle in 1860, and soon similar unions were established on other coal fields. The beginning of the 20th century saw various initiatives to form a national miners' union, and in 1909 a loose federation was set up, the Federated Coal and Shale Workers' Association. Late in 1914 further attempts were made to get an effective national union established, and in February 1915 representatives of the N.S.W. Districts (Northern, Southern and Western) as well as of Victoria/Tasmania and Queensland met to form the Australasian Coal and Shale Employees'

Note, cont. : Federation. Provisional officers were appointed : J.M.Baddeley as President, A.C.Willis as Secretary, and A.Lewis as Treasurer. The first meeting of the Central Council took place on 8 July 1915, in Sydney. In March 1916 the union registered under the Commonwealth Conciliation and Arbitration Act. This was done by amending the registration which the Victorian Branch already had had since August 1913 as the Australasian Coal Miners' Association. Also in 1916 the Cokeworkers' Association of N.S.W. affiliated with the Federation, becoming the Cokeworkers' District. Later, in 1924, they amalgamated with the Federation, though retaining separate registration in N.S.W.. The Cokeworkers' Secretary, J.M.Walker, after amalgamation worked for many years in the Federation's central office. The colliery engine drivers also affiliated in 1916, but this did not last due to the consolidation of the F.E.D.F.A.. In 1917 the United Mineworkers of New Zealand became a branch of the Federation, but after a short time this relationship became much looser, with representatives just attending each union's Annual Council meetings in alternate years. The Broken Hill miners joined the Federation in 1917, constituting the Barrier District. At various times the coal miners of Collie, Western Australia, and Leigh Creek, South Australia, and the metalliferous miners of Captain's Flat, Yerranderie and Leadville, all N.S.W., have been part of the Federation. In 1918 a congress of N.S.W. unions met on the initiative of the Federation and decided in principle to form the Workers' Industrial Union of Australia as a move towards the O.B.U.. Late in 1919 the members of the Federation voted in favour of the formation of the W.I.U. of A., and in January 1921 the Federation became the W.I.U. of A. (Mining Dept.). The Federation remained registered as the A.C.&S.E.F. and has in fact remained with both titles. In March 1920 a trial issue of "Common Cause" was published, and in July 1921 it began regular weekly publication as the official organ of the Federation. The idea of a daily newspaper for the Labour Movement had been strongly supported by the Federation and it was the moving force behind the establishment of the "Labour Daily" in 1924. From 1924 to 1935 "Common Cause" was published as a supplement in the "Labour Daily". In 1935 "Common Cause" resumed separate publication. Also in 1935 the Central Council voted to change the name of the Federation from "Australasian" to "Australian", though the two words have been used indiscriminately before and since this time.

The highest body of the Federation has been the National Convention, which has met at varying intervals since the first Convention in 1925. For a time it met every three years. The Central Council is the governing body of the Federation. It meets several times each year. It consists of the President, the Vice-President, the General Secretary, and councillors from each District. The General Secretary and, since 1925, the President are full-time paid officers. Together with the Vice-President, who is elected from the Central Councillors, they form the Central Executive.

Much of the records in this Deposit have come from the office of Cyril A. Willis. He was the son of the Federation's first General Secretary, A.C. Willis, and worked in the central office from about the mid thirties to the early seventies. He was Returning Officer from 1937 to 1971 and was at various times the Federation's Accountant, Finance Officer, Business Manager of "Common Cause".

Two histories of the Federation have been published and the above information has been based on those two works, supplemented by the records of this Deposit. The two books are :
